1.9 FAMILIARIZATION

The last two days immediately before the Championships Lake Cris will be reserved and used for Official Familiarization. This will be organized so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge based on the principle that every skier shall receive an equal opportunity for familiarization.

Slalom skiers will receive a maximum of 4 passes (or 6 minutes); trick skiers 2 passes (or 5 minutes) and jump skiers 3 jumps (or 6 minutes).

Each team requesting familiarization time shall indicate on the official Intention to Enter form time required, which must be submitted at least 60 days before the scheduled start of the event. They must indicate how many skiers in each event wish to participate. Teams who do not comply with this deadline will not be included in the familiarization schedule. At least 45 days before the scheduled start of the event, the Organizer (in consultation with the Chief Judge, whose decision shall be final) shall announce the official familiarization schedule (including the allowed time). Time will be scheduled for competitors on a random team basis, and shall be grouped by event, i.e. slalom familiarization; trick familiarization and jump familiarization (by jump height) will be grouped together. Any athlete who is not ready to ski in accordance with the schedule, will lose their official familiarization time. The Chief Judge shall have the discretion to change the start time of team's familiarization based on extraordinary circumstances.

(4 June) 60 days or more before the scheduled start of the event	Teams requiring familiarization time, must send in the request for time on the Official Intention to Enter form together with the number of skiers in each event requiring time.
(19 June) 45 days or more before the scheduled start of the event	The organizer will publish the familiarization schedule
(4 July) 30 days before the scheduled start of the event	The organizer will publish the final familiarization schedule

The maximum cost per hour for Official familiarization will be 240,00€ (4,00€ per minute). The Organizer may offer additional training during any unallocated times.

Once the familiarization schedule is **published on July 4th**, the **deadline for payment will be July 15th**. After July 15th if any slot not been confirmed through payment, anyone will be able to book any time remaining available following normal procedure.

Bye-Law 4.5.1.6. Team or individual athletes not showing up

The entry fees of team or individual athletes failing to show up after having been entered by their Federation shall still be payable in full, unless a valid written excuse is received by 12 noon of the day before the start of the competition.

Bye-Law 4.4.2. – Intention to Enter Form

An For all E&A Title Events the E&A office will send an “Intention to Enter” form to the federations. This “Intention to Enter” form has to be returned to the organising Federation and to the E&A divisional council representative to the event with a deadline of two months (June 4th) before the start of the competition.

A Federation entering a team (even of only one skier) after that deadline, will be fined 200,00€.

To be accepted, the “Intention to Enter” form must be accompanied by a deposit amounting to 50,00€ for each athlete mentioned on the form.

(For instance : 3 athletes : 3x50,00€ = 150,00€).

This amount must be paid to the organisers and is non-refundable.

This 50,00€ will be deducted from the entry fee to be paid for each athlete.

The Federation may enter up to two additional athletes more than originally declared on the “Intention to Enter” form. **If more than two additional athletes participate, then a fee of 50,00€ per additional athlete will be levied upon that Federation.**

The deadline for submitting the Intention to Enter is June 04th. For late submission of the Intention to Enter form a penalty of 200,00€ will be applied in accordance with E&A Additional Rules 1.3a.

1.11 ENTRY FORM / ENTRY FEE

In accordance with E&A Additional Rules 1.3a each Federation is required to submit the official Entry Form for the Championships. The deadline for submitting the Entry Form is July 19. For late submission of the Entry Forms a penalty of 10,00€ per day will be applied in accordance with E&A Additional Rules 1.3a.

The Entry Fee of the 2016 Seseña European+35 Waterski Championships fee is 210,00 € per competitor regardless of disciplines entered by each competitor. Entry fees can be paid by bank transfer [see 1.8] or credit via Paypal (+5%). **Deadline for payment is July 19.**

1.17 TO ENTER SPAIN

Info provided by:

Ministry of Foreign Affairs and Cooperation: <http://www.maec.es/>

The documentation you need will depend greatly on where you are coming from:

- If you are a citizen of any nation in the European Union, Switzerland, Norway, Iceland, or Liechtenstein, you will only need your National Identification Document or a current passport. For minors, the National Identification Document must be accompanied by written parental permission.
- If you are from Andorra, Argentina, Australia, Bolivia, Brazil, Brunei, Canada, Chile, Costa Rica, Croatia, El Salvador, the United States, Guatemala, Honduras, Israel, Japan, Malaysia, Mexico, Monaco, Nicaragua, New Zealand, Panama, Paraguay, the Republic of Korea, Romania, San Marino, the Vatican, Singapore, Uruguay, or Venezuela you will need to show a valid passport to enter Spain. Your stay may not exceed 90 days.
- If you are coming from any other country, in accordance with EU regulations, you must apply for a visa at the Spanish Consulate for your country. You must also show an official passport. In this case, Spanish authorities may require proof of accommodation, reservation confirmation by an official travel agency, a return ticket, tour agenda, or personal invitation. Likewise, you may be required to provide proof of sufficient funds to cover your stay in Spain.

As the conditions stated above may vary, we recommend you contact the Spanish Consulate or Embassy for your country to ensure you meet all requirements before traveling.

I do hereby authorize any and all physicians, paramedics and other medical personnel and practitioners procured by, or on behalf of, the IWWF and the Organizer to administer first aid treatment, or any medical treatment, surgery or transportation in the event of any illness, accident or injury suffered and/or sustained by me at any time during my participation and competition in the Championships (or any part thereof) and hereby indemnify, and shall keep fully and effectively indemnified, the IWWF and the Organizer (including all directors, officers, employees, volunteer and other representatives thereof) upon demand from and against any and all claims, liabilities, demands, costs and expenses of whatsoever nature incurred and/or suffered by the same (or any of them) and arising from, and/or in connection with, the procurement and administration of such medical treatment and transportation in relation to any such illness accident or injury suffered and/or sustained by me;
